

Privacy Policy

JGI, Inc. (JGI) will comply with the Act on the Protection of Personal Information and the Personal Information Protection Commission Guidelines when handling Personal Information acquired in the course of business.

1. Safety Management Measures

JGI takes necessary and appropriate measures to protect the acquired Personal Information, including preventing falsification, leakage, and loss of Personal Information handled by JGI.

2. Compliance with Purpose of Use

JGI uses the acquired Personal Information only within the scope of the purpose of use, within where required by laws and regulations, or where prior consent has been obtained from the person.

3. Provision of Personal Information to Third Parties

Except in the following cases, JGI will not provide the acquired Personal Information to third parties without the prior consent of the person.

- ① Cases where the provision is required by laws and regulations
- ② Cases where the provision is necessary for protection of the life, body, or property of an individual and where it is difficult to obtain the consent of the person
- ③ Cases where the handling of personal information is entrusted to a company, etc. with which JGI has entered into a confidentiality agreement with the company to the extent necessary for the achievement of our purpose of use
- ④ Cases where the provision is specially necessary for improving public hygiene or promoting the sound growth of children and in which it is difficult to obtain the consent of the person
- ⑤ Cases where the provision is necessary for cooperating with a government institution, a local public body, or an entity commissioned by them in executing the operations prescribed by laws, and where obtaining the consent of the person might impede the execution of the operations concerned

In the event that JGI entrusts all or part of Personal Information handling to a third party, we will thoroughly examine the party's qualifications and exercise necessary and appropriate supervision to ensure secure management of the Personal Information entrusted to them.

4. Sharing Personal Information

JGI may share the acquired Personal Information as described below, with the prior consent of the person.

- ① Items of personal data shared

Company name, affiliation, position, work history, name, address, telephone number, fax

number, and email address

- ② Scope of parties to share the information
JGI, JAPEX, and their consolidated subsidiaries.
- ③ Purposes of use by parties sharing the information
Purposes of use notified to the individual at the time of acquisition of personal information
- ④ Party responsible for the management of Personal Information shared

5. Handling of personal information on our website

6. Disclosure

If requested by a person to disclose their Personal Information, JGI will disclose it to the person promptly.

7. Improvement and Review of Personal Information Handling

JGI endeavors to inspect the handling of Personal Information and make improvements appropriately.

8. Disposal of Personal Information

JGI shall delete or dispose of Personal Information when it is no longer necessary for the intended purpose. Such deletion and disposal shall be conducted in a necessary and appropriate manner to prevent risks such as external leakage.
